

### **California Competes Tax Credit**

Income tax credit available to businesses that want to locate in California or stay and grow in California

### **California Employment Training Panel**

Funding provided to employers to assist in upgrading the worker skills through training that leads to good paying, long-term jobs

### **California Film and tax Credit Program**

Tax credit incentive to qualified motion pictures

### **California Hybrid and zero Emission Truck and Bus Voucher Incentive**

A streamlined incentive program to help speed the purchase of clean, hybrid, and electric trucks and buses and is designed to assist fleets and dealers by reducing vehicle cost right at the time of purchase. Vouchers range from \$18,000 to \$95,000 per vehicle on a first-come, first-served basis. Additional funding for some vehicles available as well.

### **California Manufacturing Technology Consulting**

### **California Sales and Use Tax Exclusions**

Sales and use tax exclusion for manufacturers that promote alternative energy and advanced transportation. This program is currently authorized through 2020.

### **California Sales and Use tax Exemption**

Sales and Use tax exemption that manufacturers and certain research and developers may qualify for on certain manufacturing and research and development equipment purchases and leases

### **California State New Employment Credit**

Available for employers who hire long-term unemployed, unemployed veterans, ex-felons, or recipients of public assistance in designated high unemployment and poverty census tracts.

### **California State Research & Development Tax Credit**

R&D firms may receive a credit against their bank and corporation tax liability for in house research expenses and basic research payments to outside organizations. Research must be conducted within CA and include basic or applied research of scientific inquiry, original investigation or improved function of a business component.

Tax credits for Employers and firms that hire veterans

### **EB-5 Immigrant Investor Program**

Foreign nationals are eligible to receive permanent resident status for qualifying investments; reduced qualified investment within targeted employment areas

### **Federal Investment Tax Credit**

To reduce federal income taxes for qualified tax-paying owners based on capital investment in renewable energy projects

### **Governor's Office of Business and Economic Development (GO-Biz)**

Serves as California's single point of contact for economic development and job creation efforts. GO-Biz offers a range of services to business owners including: attraction, retention and expansion services, site selection, permit assistance, regulatory guidance, small business assistance, international trade development, assistance with state government, and much more.

### **CALGOLD Permit locator**

Assists in finding appropriate permit information for businesses. It also provides contact information for the various agencies that administer & issue these permits.

### **CA Ibank Industrial Development Bonds**

Conduit tax-exempt and taxable bond financing for private business expansion for qualified small manufacturing and processing businesses
