### Item 6: DCBA Legislative Update

Wason Fu, DCBA Senior Policy Analyst, provided an update on Assembly Bill 539 which aims at providing affordable and accessible credit to consumers by establishing an annual interest rate cap on personal loans. Mr. Fu went on to describe the harsh rates that high cost lenders charge on loans above \$2,500 and the need to impose caps to prevent families from financial harm. Currently the bill is progressing through the Senate.

Following the presentation, Commissioner Chiles motioned to delegate the Chair to write a letter of support for AB 539 on behalf of the Commission to the Director of DCBA and the Chief Executive Office of LA County (CEO). Commissioner Chan seconded. The motion passed as follows:

#### **Item 7: Department Update**

Maritza Gutierrez, Supervisor for Consumer Counseling, presented information on the Parks After Dark Program currently running throughout LA County. Ms. Gutierrez also noted that DCBA has received a prestigious award from the National Association of Counties (NACo) for the Online Dispute Resolution (ODR) program. Finally, Mrs. Gutierrez outlined the current outlook for counseling services and the objective of cross-training counseling staff across all topics within consumer protection to better serve the public.

Director of DCBA Joseph Nicchitta provided updates on Assembly Bills 1753, 549 and 1106. Additionally, Director Nicchitta stated that DCBA is currently in the process of strategic planning and is trying to expand the wage enforcement and investigations program.

Chief Deputy Director Joel Ayala shared that the Department is working on a permanent ordinance for rent stabilization that would include mobile parks. A brief update on ICE raids within LA County was also mentioned.
