## **Item 3: Approval of Small Business Commission Minutes**

Commissioner Araujo moved to approve the minutes of the Small Business Commission meeting for March 10, 2019. The motion was seconded by Commissioner Allen. Motion passed unanimously.

### **Item 4: County Contracting - ISD**

Christie Carr, Contracts Division Manager from the Internal Services Department (ISD), presented on the Local Small Business Enterprise (LSBE) and Community Business Enterprise (CBE) contracting goals for LA County, updates to the "Doing Business With LA County" website and the efforts made by ISD to meet their utilization goals. In addition, Ms. Carr highlighted important insurance requirements that should be considered with any County service contract.

## Item 5: S.M.A.R.T Funding - LACDA

Carey Jenkins, of the Los Angeles Community Development Authority (LACDA), provided information on the S.M.A.R.T Funding Loan Program which aims at providing manageable loans to a wide range of businesses located in LA County. Mr. Jenkins further explained that the program continues to successfully process applicants within a 60 to 90-day window.

## Item 6: Preference Program Ordinance Amendments - OSB

Christian Olmos from the Office of Small Business (OSB) presented a summary of the amendments made to the LSBE, Disabled Veteran Business Enterprise (DVBE) and Social Enterprise (SE) ordinances. Mr. Olmos elaborated that the new amendments will aim at providing more clarification to the language of the ordinances and will establish a new set of guidelines.
