


# 3. RESPONSE TO COVID-19


DCBA began mobilizing its operation to respond to the COVID-19 emergency since late January. Since then the Department:


- Is now operating 100% remotely providing services to the public
- Participated in multiple press conferences, webinars, and meetings to raise awareness of COVID-19 best practices to reduce risk of infection and to share information about County, State, and Federal resources available to impacted businesses
- Produced an informational video to raise awareness of the declared public health emergency and available resources to businesses
  - 1. Video circulated via email, social media, and <u>YouTube</u> (<u>https://youtu.be/NqGjV39KWpo</u>)
  - 2. Translated into Spanish and Chinese
- On March 26, 2020, launched a **Business and Worker Help Center**, in partnership with the Workforce Development, Aging and Community Services (WDACS) and the Los Angeles County Development Authority (LACDA). This Center serves three functions:
  - 1. Serve as a single-entry point for businesses and workers;
  - 2. Centralize access to emergency resources into a single portal; and
  - 3. Provide direct 1-1 assistance to those with high needs.
