Item 1: Call to Order

Executive Committee Chair Gomez called the meeting to order at 10:04 a.m.

Item 3: Approval of Executive Committee Meeting Minutes

Commissioner Ostroy moved to approve the minutes of the August 21, 2020, Consumer Affairs Advisory Commission (CAAC) Executive Committee meeting. The motion was seconded by Commissioner Jayne. Motion passed unanimously.

Commissioner Gorman stated that the Legislative Committee received information on Assembly Bill 3088, which grants additional eviction protections to Los Angeles County residents. Commissioner Jayne stated that the Public Information Committee meeting received information on a website developed by the Internal Services Department (ISD) in partnership with the Los Angeles County Library, that provides information on free WIFI access points located across Los Angeles County. The Committee also received an update from the Department of Consumer and Business Affairs (DCBA) Public Information team on the new changes that were made to the DCBA website. Commissioner Jayne recommended that this information be shared at the next CAAC meeting.

Maggie Becerra, DCBA Deputy Director of Consumer Counseling, and Maritza Gutierrez, DCBA Chief of Consumer Counseling, provided information on recent notable settlement agreements made with employers violating minimum wage ordinances in Los Angeles County.
