# Item 3: Approval of Consumer Affairs Advisory Commission (CAAC) Minutes

Commissioner Leon moved to approve the minutes of the CAAC meeting for November 19, 2020. The motion was seconded by Commissioner Ostroy. Motion was passed with Commissioner Rodarte abstaining from the vote.

### Item 4: Approval of CAAC 2021 Meeting Calendar

Francisco Mendez, Department of Consumer and Business Affairs (DCBA) Commission Services Liaison, presented the CAAC 2021 Meting Calendar. Commissioner Chan moved to accept and approve the meeting calendar as presented. Commissioner Leon seconded the motion. The motion was unanimously passed via roll-call vote.

#### Item 5: 2021 Nominations and Elections Update

Francisco Mendez, DCBA Commission Services Liaison, shared information on the upcoming election process for the selection of Commission Chair and Vice-Chair for calendar year 2021. Among the shared information, Mr. Mendez informed the CAAC that elections will take place at the first CAAC meeting, scheduled for January 21, 2021 at 10:30 a.m.

### Item 6: DCBA - Update on Assembly Bill (AB) 3088

Maritza Gutierrez, DCBA Chief of Mediation and Counseling, shared information on how AB 3088 has impacted the mediation program administered by the DCBA. Ms. Gutierrez also shared how virtual alternative service methods have been developed and implemented by the mediation team in response to the COVID-19 pandemic. Information on newly developed tools, resources, and outreach efforts made by DCBA was also shared.

#### Item 7: DCBA - Information on Common Scams

Keven Chavez, DCBA Public Information Officer, shared information and updates on common holiday scams that were prevalent during the holiday season. Information on general scams that Los Angeles County residents should be aware of, as well as, tips, tools available to help identify these scams, and ways that residents can report suspected scams was also shared.

#### Item 8: CAAC Legislative and Public Information Committee Updates

Commissioner Jayne, Chair of the Public Information Committee, stated that the Committee received information on holiday and common scams targeting Los Angeles County residents.
