If all parties agree on a settlement by their ODR deadline, ODR will help you electronically file the required forms with the court at no charge and you will not have to attend your court hearing or trial.

If all parties cannot agree on a settlement by their ODR deadline, all parties must attend the scheduled hearing or trial.
