#### Item 3: Approval of Executive Committee Meeting Minutes

# Item 4: County of Los Angeles Executive Office of the Board of Supervisors – Update to Memo Regarding Commission Guidance – Preparing to Reopen

David Diaz, Department of Consumer and Business Affairs (DCBA) Commission Services Liaison, shared information on Executive Order N-08-21, an order made by Governor Newsom that allowed certain provisions of the Ralph M. Brown Act to be suspended in response to COVID-19. The Executive Order will be repealed in the future, and updates will be shared when available.
