### **Meeting Held Via Teleconference**

Item 1: Call to Order

Executive Committee Chair Ostroy called the meeting to order at 10:21 a.m.

### **Item 3: Approval of Executive Committee Meeting Minutes**

Commissioner Gorman moved to approve the minutes of the August 19, 2021, Consumer Affairs Advisory Commission (CAAC) Executive Committee meeting. The motion was seconded by Commissioner Jayne. The motion was passed unanimously via voice vote.

#### Item 4: CAAC - Approval of 2022 CAAC Meeting Calendar

The Executive Committee reviewed the 2022 CAAC Meeting Calendar. After review, Commissioner Jayne moved to accept the calendar and present the accepted version for review and approval by the CAAC at the next full body CAAC meeting. # Item 5: County of Los Angeles Executive Office of the Board of Supervisors – Commission Guidance Under Assembly Bill (AB) 361

Francisco Mendez, Department of Consumer and Business Affairs (DCBA) Commission Services Liaison, shared updated information on AB 361, which would allow the continuance of teleconferenced meetings under a declared state of emergency. As mentioned, Commission meetings will continue to be held via teleconference until further guidance is issued by the Executive Office of the Board of Supervisors.

Francisco Mendez updated the Executive Committee membership regarding the status of the newly added standing item for the CAAC full body meeting in relation to 2021 Commission Goal Number 5. Commissioner Harry Leon, Chair of the Legislative Committee, shared that the Committee received a presentation on the DCBA Rent Registry Portal and recommended that a presentation on the portal be shared with the CAAC once more data is available. Commissioner Ronnie Jayne, Chair of the Public Information Committee shared that the Committee will receive a presentation from the DCBA Office of Immigrant Affairs on the recently launched Immigrant Services Map.

#### **Item 9: DCBA Department Update**

Maggie Becerra, Deputy Director of Consumer Counseling for DCBA, shared that walk-in services at the DCBA main office in the Hall of Records are now resumed. Los Angeles County Residents are able to schedule appointments through the DCBA website or can walk-in to receive services in person. Information on the reopening of DCBA branch offices will be shared when available.
