Item 3: Approval of Consumer Affairs Advisory Commission (CAAC) Minutes

Commissioner Gomez moved to approve the minutes of the CAAC meeting for July 21, 2022. The motion was seconded by Commissioner Ostroy. Motion to approve was passed unanimously via voice vote.

Item 4: CAAC - Continuation of Assembly Bill 361

Taryn Lyon, Department of Consumer and Business Affairs (DCBA) Commission Services Liaison, shared that teleconferencing will continue until further notice.

Item 5: CAAC – Information on 2021 CAAC Annual Report

Taryn Lyon conducted a demonstration of the DCBA CAAC website that highlighted the location of the meeting materials, Commissioner biographies, and previous annual reports.
