

In 2022, she fielded almost 1000 borrower student loan inquiries and helped borrowers receive over \$650,000 in PSLF forgiveness.

Celina has worked for the State of California for over 15 years and has extensive experience in analytical, enforcement, legal and outreach work. She has served different populations including children, families, and low wage workers with a focus on empowering individuals through education and outreach. At the DFPI, Celina will continue to build a successful student loan program to support and protect California borrowers in the coming years.




**Anna Darr**Elder Justice and Holocaust Survivor Services Attorney

Anna Darr is an Elder Justice and Holocaust Survivor Services Attorney at Bet Tzedek Legal Services in Los Angeles. Her work with local survivors involves a broad array of elder law and poverty law issues, with a focus on advance planning and planning for incapacity and end of life. She works with clients to draft planning documents including advance health care directives, powers of attorney for finances, and wills and trusts. Anna also presents on these topics to community members and professionals, highlighting the integration of person-centered trauma informed care. Anna co-created Bet Tzedek's Decedents' Estates Clinic in partnership with the Los Angeles Superior Court and continues to pursue equal access to justice for underserved vulnerable communities through advocacy and community partnerships. Anna has been with Bet Tzedek for 8 years, prior to which she worked in civil litigation. Anna received her undergraduate degree in Political Science from SUNY Purchase, and her law degree from Southwestern Law School.






#### Mary Salinas Durón
