### THIS IS NOT AN APPLICATION FOR EMPLOYMENT

- 1. You can apply to serve as a commissioner if you are at least 18 years of age **and** either:
  - <u>A renter</u> whose primary residence is a dwelling unit subject to the Los Angeles County Rent Stabilization and Tenant Protections Ordinance (RSTPO) (Los Angeles County Code, Chapter 8.52) or <u>a renter</u> whose primary residence is a mobile home park space subject to the Los Angeles County Mobilehome Rent Stabilization and Mobilehome Owner Protections Ordinance (MRSMOPO) (Los Angeles County Code, Chapter 8.57). Members must reside in the unincorporated area of Los Angeles County.
  - <u>An owner</u> of a dwelling unit subject to the RSTPO or <u>an owner</u> of a mobile home park that is subject to the MRSMOPO.
  - <u>An individual</u> who is affiliated with an organization that represents the interests of any of the previously mentioned parties.




