# CONSUMER COUNSELING & COMPLAINT INVESTIGATION

We can help with:

- Purchases and refunds
- Credit
- Car Sales

We can investigate complaints about:

We can refer cases involving serious offenders to local law-enforcement agencies for review, when appropriate.



#### TENANT AND HOUSING PROTECTIONS

We enforce Rent Stabilization and Tenant Protections Ordinances for homes and mobilehomes in unincorporated areas of LA County and manage LA County's Rent Registry.
